All the Photostat copies submitted by the candidates will have to be self attested by the candidate.

X. PHYSICAL STANDARD TEST:-

After the Call letter and the identity are found correct, the candidates will be asked to appear in the PST. The PST will carry no marks. Measurement of the height, weight and chest (only for Male & Transgender) of the candidates will be taken after which the candidate will be inspected by a medical officer for preliminary checkup like knocked knee, vision test, colour blindness test, flat foot, varicose vein, physical deformities etc. Varicose vein shall be considered a temporary disqualification. Once a candidate clears the PST, he/she will have to appear in the Physical Efficiency Test (PET).

XI. PHYSICAL EFFICIENCY TEST- 80 MARKS FOR MALE & TRANSGENDER AND 60 MARKS FOR FEMALE:

Candidates who clear PST, will be required to undergo PET. The PET consists of the following:

The Physical Efficiency Test will carry 80 marks (Male & Transgender)/ 60 marks (female) It will have **FOUR** events for Male & Transgender and **THREE** events for female.

i) Male & Transgender Candidates

- a. **4.8 km Race:** Those who qualify in the PST will be subjected to 4.8 km race to be completed within 20 minutes.
- b. **Long Jump:** Minimum 305 cm for long jump (3 chances to be given and the longest valid jump rounded off to the nearest cm will be considered for awarding marks).
- c. **Chin Up:-** 10 times is for qualifying.
- d. **100 meter Race.** To be completed within 15 seconds.

Instructions for conduct of PST/ PET

- A candidate gets eliminated from the recruitment process as soon as he/ she fails to qualify in any event during PST or PET. A candidate may have to take the PET in a sequence as decided by the Recruitment Board.
- Individual statement of marks signed by the candidate and the officer conducting the race/ tests will be shown to the candidates. A registration slip will be given to a candidate when he/she is eliminated from a particular Test.
- CCTV will be installed for recording each event of the PST and PET for each candidate. Performances may also be announced through PA system.
- All Candidates will be subjected to biometric recordings for identification.
- Results of the PST and PET will be locally displayed at the end of each day of Test. However, candidates shall have no claim or right to appear in the Written Test merely on the ground that they secured the minimum qualifying standards in the PST and PET. After completion of the PST and PET for all the candidates, District-wise merit lists for each category (Unreserved, OBC/MOBC, SC, ST(P), ST(H) for both men and women) will be prepared on the basis of the total marks scored on PET.

XII. PSYCHOMETRIC TEST : Maximum Marks - 20

All candidates who clear PST/PET will have to appear in a PSYCHOMETRIC TEST. An eminent panel of experts will be constituted preferably from CAPF, Army who have experiences in raising special forces and draw up a methodology on the following:

- Mental framework to carry out hard work.
- Adaptability of jungle/ hilly terrain/ ecology.
- Apritude/ Atritude measurement.

The Psychometric test will be conducted under the chairmanship of an eminent personality from Army / CAPF. The panel will comprise of representative from ARMY / CPMF and one senior serving officer/ retired officer of Assam Police.

The panel members will be selected from officers with experience of raising special forces.

XIII. FINAL RESULT :

Final results would be based on the marks obtained as follows:

A) FOR MALE & TRANSGENDER CADIDATES

i. Written Test	Maximum marks 100
ii. Marks for PET	Maximum marks 80
iii. Psychometric Test	Maximum marks 20

Total- 200

B) FOR FEMALE CADIDATES

i. Written Test-	Maximum marks 100
ii. Marks for PET-	Maximum marks 60
iii. Psychometric Test.	Maximum marks 20

Total- 180

There will be only ONE merit list for each category i.e. Unreserved/OBC/MOBC/SC/ST(P)/ST(H), Sports Person & EWS, separately for Male & Transgender and female for the entire State. Select list will be prepared for the exact number of vacancies to be filled up.

N.B:

- In case of a tie in marks, the candidate older in age will be placed higher in the merit list. Further, candidates having same date of birth and have obtained equal marks, will be placed in the merit list according to higher height.
- In case, posts reserved for EWS are not filled up by candidates belonging to EWS category due to shortage of the eligible candidates, the posts will be filled up from the candidate of unreserved category.

XIV. GENERAL INSTRUCTIONS TO THE CANDIDATES :-

- Based on the aggregate performance of the candidates in the Written test, Physical Test, and Psychometric Test, selection will be made category-wise for the post of Sub-Inspector (AT) subject to the condition of successful completion of their character and antecedents verification and satisfactory Medical report from the competent authorities. The total numbers of finally selected candidates will be equal to the numbers of the existing vacancies advertised.
- The candidates who are employees of Govt. / PSUs / Autonomous bodies must obtain necessary permission in writing from the Competent Authority / Employer and a copy of the same may be produced during scrutiny of documents on the date of PST / PET.
- On selection, candidates will be put through a prescribed course of training for 1 (one) year which includes regular physical training and class room session. During the period of training, they will be treated as probationary SI (AT) of Police and will be entitled to get usual pay and other allowances. Those who fail in the final examination after completion of training or are involved in gross misconduct or indiscipline will be liable to be discharged forthwith without assigning any further reason.
- Candidates selected for the post of Sub-Inspectors (AT), may be posted in any branch of Assam Police.
- Canvassing directly or indirectly shall render such candidates unfit for the post.
- No TA / DA will be admissible to candidates for the journey and stay at any stage of the recruitment process.
- The selection list confers no right to appointment unless the department is satisfied about suitability of the candidate after a thorough medical examination and such enquiry and verification as may be considered necessary before appointment to the service / post.
- Candidates have to appear in all the stages of recruitment. If a candidate is absent from any stage / event, his / her candidature will be cancelled.
- Candidate will be summarily rejected at any stage of the recruitment process, if found not conforming to the official format / having incomplete information / wrong information/incomplete requisite certificate/misrepresentation of facts / impersonation.
- The select list will remain valid for appointment from date of announcement of the result for one year or till the date of next advertisement of similar post whichever is earlier.
- On appointment, the candidate shall be governed by the Assam Police Act, 2007 and Rules and Orders of the Government issued from time to time.
- Appointed persons shall be entitled to pension benefits as per the pension scheme existing at the time of appointment.
- The Chairman, SLPRB, Assam reserves the right to make changes or cancel or postpone the recruitment process on specific grounds.
- The physical tests are strenuous and candidates who are in proper medical condition only should take the tests. The SLPRB will not be liable for any injury or casualty suffered by a candidate during the tests due to any pre-existing medical condition of the candidate concerned.
- Fake documents / false information / misrepresentation of facts shall lead to rejection if detected at any stage before / after appointment and shall make the candidate liable to criminal proceeding as per existing law.
- Selected candidates shall have to sign an agreement whereby he / she will be required to serve a minimum period of 3 (three) years after successful completion of training or in default to refund the cost of training and travelling expenses paid by the government.
- Offering of bribe or any favour by a candidate or by any individual on behalf of any candidate is a criminal offence. Such an activity shall result in immediate disqualification of the candidature of that particular candidate.
- In case of any clarification, the decision of the Selection Board will be final.
- The number of posts (vacancies) are subject to change and appointment to such vacancies will be decided by the competent authority at the time of appointment, based on merit, category wise as per the final merit list.
- The final appointment after selection is subject to satisfactory Police Verification Report and Final Medical Examination Report as per existing norms. In case Police Verification Report or Final Medical Examination Report is found unsatisfactory, the candidature of such candidates will be rejected outright.
- The rules & regulations, terms & conditions of training and afterwards will be applicable as prevalent in Assam Police.

XVI. TRANSPARENT PROCESS:

- Candidates and the general public are requested to help SLPRB in conducting the recruitment in a just, fair and transparent manner.
- A candidate is NOT required, to pay any amount of money at any stage of the recruitment process except for medical investigations, if required in the Govt. hospital.
